

## **TERMS AND CONDITIONS FOR TRAINING COURSES**

### **Reservations**

Provisional bookings may be accepted over the telephone, these however must be confirmed in writing, at least three weeks prior to the commencement of the course. Whitstable Powerboat Training reserves the right to re-allocate places where this confirmation has not been received.

### **Fees**

Fees may be subject to alteration and should be confirmed at the time of booking. Fees are per delegate and include all tuition and documentation and light refreshments only unless otherwise specified.

### **Payment**

All accounts are payable in full within 14 days of receipt of an invoice. Where delegates are individuals cheques are to be paid on or before course registration. Certificates will only be released once full payment has been made. Payment can be made by cash, cheque or bank transfer only. Cheques are payable to **Shoreside Consulting Limited**.

### **Confirmation**

On receipt of a signed contract or written purchase order, we will post, fax or email confirmation of the course, (please indicate your preferred option) which will include directions and a supporting map showing the course venue, along with details of local hotels if applicable. Until the contract or purchase order has been received, confirmation cannot be given.

### **Cancellation**

You may cancel a scheduled course and be refunded all course fees provided more than 21 working days notice (working days excludes all statutory bank holidays) is given. All cancellations must be received in writing and acknowledged by Whitstable Powerboat Training. Delegates may be substituted at any time up to course commencement. In the event of cancellation the following charges will be applied.

In a situation where a course is run exclusively for a customer - on a customer site or any other alternative venue - the same cancellation terms apply. In the event that it is necessary for Whitstable Powerboat Training to cancel or reschedule a course, we will endeavour to give a minimum of 21 days working days notice. In such circumstances a full refund or alternative dates will be available and all liability by Whitstable Powerboat Training will be limited to the value of the original course fee.

### **Course Content**

All course material, content and visual aids are copyright Whitstable Powerboat Training and may not be reproduced in any form without the express written permission of Whitstable Powerboat Training.

### **Safety**
